This case having been heard finally on the 16th day of March, 2026 the court on the same day delivered the following:-

ORDER

1. This case is taken on file upon a final report filed by the Inspector of Police, Guruvayoor Police Station in Cr. No. 522/2025 of that Police Station, against the accused alleging offences punishable under sections 126(2), 115(2), 74, 75(1), 296(b), 351 of BNS.

2. The prosecution case in brief is that, on 26/05/2025 at 20:00 hours, when the defacto complainant and her friend were standing in front of a shop to evade the rain, accused wrongfully restrained her and uttered obscene words against her and slapped on her face. Accused neglecting her objection, with the intention to have sexual favor, forcefully pushed on her breast, intimidated to kill her and kicked on her abdomen and caused her to fall on the road. The accused thereby outraged her modesty. The accused

is thereby alleged to have committed offences punishable under sections 126(2), 115(2), 74, 75(1), 296(b), 351 of BNS.

3. The accused was released on bail. On appearance of the accused through counsel, copies of all relevant prosecution records were furnished to him.

4. The offences alleged against the accused are exclusively triable by the Hon'ble Court of Session. Hence, this case is committed to the Hon'ble Court of Session, Thrissur under section 232(a) of BNSS for trial.

5. Transmit the case records forthwith to the Hon'ble Court of Session and properties, if any, as and when required. Committal of the case shall be intimated to the Public Prosecutor, Thrissur. The accused is directed to appear before the Hon'ble Court of Session, Thrissur as and when so directed by the said Court.
