- Finding : The offences are exclusively triable by the Hon'ble Sessions Court, Thrissur.
- Order : The case of accused is committed to the Hon'ble Sessions Court, Thrissur for trial U/s. 232(a) of BNSS.

This case having been heard finally on the 5th day of May, 2026 the court on the same day delivered the following:-

ORDER

1. This case is taken on file upon a final report filed by the Sub Inspector of Police, Guruvayoor Police Station in Cr. No. 652/2025 of that Police Station, against the accused alleging offences punishable under sections 118(1), 110 of BNS, 2023.

2. The prosecution case in brief is that on 19/07/2025 at 22:30 hours, on the road in front of the rental house of defacto complainant at Ariyannur, accused armed with chopping knife and wooden block as dangerous weapons, due to previous animosity with the son of the defacto complainant hit him with wooden block on his back. On hearing about the incident, when the defacto complainant questioned the accused, accused cut her with a chopping knife to her head and she thereby sustained injury on her forehead and needed 5 stitches there. Had the defacto complainant not evaded the second attack with

chopping knife to her head, it would have caused injury to her vital parts and thereby resulted into her death. The accused has thereby committed offences punishable under sections 118(1), 110 of BNS, 2023.

3. Accused was released on bail. On appearance of the accused through counsel, copies of all relevant prosecution records were furnished to him.

4. The offences alleged against the accused are exclusively triable by the Hon'ble Court of Session. Hence, this case is committed to the Hon'ble Court of Session, Thrissur under section 232(a) of BNSS for trial.

5. Transmit the case records forthwith to the Hon'ble Court of Session and properties, if any, as and when required. Committal of the case shall be intimated to the Public Prosecutor, Thrissur. Accused is directed to appear before the Hon'ble Court of Session, Thrissur as and when so directed by the said Court.
