- Finding : The offences are exclusively triable by the Hon'ble Sessions Court, Thrissur.
- Order : The case is committed to the Hon'ble Sessions Court, Thrissur for trial U/s. 232(a) of BNSS.

This case having been heard finally on the 6th day of April, 2026 the court on the same day delivered the following:-

ORDER

1. This case is taken on file upon a final report filed by the Sub Inspector of Police, Chavakkad Police Station in Cr. No. 1034/2020 of that Police Station, against the accused alleging offences punishable under sections 341, 323, 324, 308, 506 r/w 34 IPC.

2. The prosecution case in brief is that on 02.07.2020 at about 04.20PM, the accused had wrongfully restrained the defacto complainant at Edakkazhiyur and the 1st accused had attacked the defacto complainant by beating with an iron rod and the petitioner caught hold of the defacto complainant and kicked. The 3rd accused had also inflicted injury to the defacto complainant by hitting him with a stone. Thus, the petitioner and other accused are alleged to have committed the aforesaid offences. The accused has thereby committed offence punishable under sections 341, 323, 324, 308, 506 r/w 34 of the Indian Penal Code.

3. Initially the case was taken on file as CP 41/2021 of this court. In this case, the case against accused No. 1 was already committed to the Hon'ble Sessions Court as per order dated 22-02-2022. Since the 2nd and 3rd accused were absconding, the case against them was split up and refiled as CP 18/2022. Since the accused were continuously absconding, the case was transferred to LPR as LP 68/2022. On appearance of 3rd accused in LP 68/2022, case against him was taken from LP and refiled as CP 90/2022, ie. the present case. Accused was released on bail. On appearance of the accused through counsel, copies of all relevant prosecution records were furnished to him.

4. The offences alleged against the accused are exclusively triable by the Hon'ble Court of Session. Hence, this case is committed to the Hon'ble Court of Session, Thrissur under section 232(a) of BNSS for trial.

5. Transmit the case records forthwith to the Hon'ble Court of Session and properties, if any, as and when required. Committal of the case shall be intimated to the Public Prosecutor, Thrissur. Accused is directed to appear before the Hon'ble Court of Session, Thrissur as and when so directed by the said Court.
