ORDER

This is a petition filed under Order 6 Rule 17 for
amendment of injunction petition in IA.1/2025. The plaintiff

wrongly incorporated the plaint 'B' schedule after the 'D' schedule instead of 'C' schedule. This is a mistake occurred from the side of the plaintiff.
