**ORDER**

This case is instituted on a final report filed by the Sub Inspector of Police, Chalaky Police Station in Crime No.78/2025 alleging offence punishable under sections 126(2), 115(2), and 3(5) of Bharatiya Nyaya Sanhita, 2023.

2. The prosecution case in brief is that, accused numbers 1 to 4 in furtherance of their common intention on 18.01.2025 at 21.45 hours, at Koodapuzha, wrongfully restrained CW1 and 3<sup>rd</sup> accused voluntarily caused hurt to him by beating on his forehead and 2<sup>nd</sup> accused kicked him. Accused altogether attacked CW1 by hitting on various parts of his body and by kicking. CW2, wife of CW1 is tried to obstruct the accused and accused pushed her. Her child who was on her hand also fell down and sustained injuries. Thus, the accused are alleged to have committed the aforementioned offences.

3. On appearance of the accused (1 to 3) before court, copies of all relevant

prosecution records were furnished to them and thereby the requirements under Sec.230 of Bharatiya Nagarik Suraksha Sanhita ( In short "BNSS") was complied with. Accused are represented by a counsel of their choice. They are on bail. Accused No.4 is absconding.

4. The child, who was on the hand of CW2 fell down and sustained injuries in the accident. The child is not included in the witness list.

5. On perusal of the case records, it appears to me that the offences alleged against the accused is exclusively triable by a special court which is Children's Court since the child who was in the hand of CW2 fell down and sustained injuries . **As per S.25 of Commission for Protection of Child Rights Act, 2005** this case is ought to be committed to the Children's Court. Therefore, the case against accused is hereby committed to the Children's Court, which is Hon'ble Sessions Court, Thrissur. The case records shall be forwarded to Hon'ble Sessions Court, the property produced if any shall be subject to rule 79(2) of BNSS.

6. Accused (1 to3) are directed to appear before the Hon'ble Sessions Court on summons u/s.232(b) of BNSS. Case against accused No.4 is split up and refiled as CP. 157/2025.

7. The case records and properties shall be submitted under Sec.232(c) of BNSS before the Hon'ble Sessions Court when summoned.

8. The Public Prosecutor, Thrissur shall be notified regarding the committal of the case under Sec. 232(d) of BNSS.
