**ORDER**

This case is instituted on a final report filed by the Sub Inspector of Police, Aloor Police Station in Crime No.760/25 alleging offence punishable under sections 126(2),118(1),296(b),115(2) and 110 r/w Sec.3(5) of Bharatiya Nyaya Sanhita, 2023.

2. The prosecution case in brief is that, on 19.09.2025 at 17.45 hours, the accused two in numbers in furtherance of their common intention due to enmity towards the CW1 at the road near Poovasserykavu temple, they wrongfully restrained him and uttered obscene words against him and hit behind his head with a metal

bangle and 2<sup>nd</sup> accused hit on his back. It is also alleged that the first accused again hit on the nose of CW1 with a metal bangle and it could have been resulted in the death of CW1 unless he slightly escaped from the same. Thus, the accused are alleged to have committed the above mentioned offences.

3. On appearance of the accused before court, copies of all relevant prosecution records were furnished to the accused and thereby the requirements under Sec.230 of Bharatiya Nagarik Suraksha Sanhita ( In short "BNSS") was complied with. Accused are represented by a counsel of their choice. They are on bail.

4. On perusal of available materials, it appears to me that the offence alleged against accused is exclusively triable by the Court of Sessions. Therefore, the case against accused is committed to Hon'ble Sessions Court, Thrissur for trial as provided under Sec. 232(a) of BNSS. The case records shall be forwarded to Hon'ble Sessions Court, the property produced if any shall be subject to rule 79(2) of BNSS.

5. Accused are directed to appear before the Hon'ble Sessions Court on summons u/s.232(b) of BNSS.

6. The case records and properties shall be submitted under Sec.232(c) of BNSS before the Hon'ble Sessions Court when summoned.

7. The Public Prosecutor, Thrissur shall be notified regarding the committal of the case under Sec. 232(d) of BNSS.
