**ORDER**

This is a case taken on file upon a final report submitted by the Excise Circle Inspector, Excise Kunnamkulam in Cr. 22/2025 for the alleged commission of offence punishable U/s. 8(1) & (2) of Abkari Act of 1077.

2. The prosecution case is that, on 23.02.24 at 12.15 PM at Kurumal desam the accused was found in possession of 11 liter of arrack, which was kept in the house at Kurumal desom and there by alleged to committed offences punishable U/s. 8(1) & 8(2) of Abkari Act of 1077.

3. Accused appeared and enlarged on bail. Copies of all relevant records was given to him u/s. 230 BNSS.

4. Heard the Assistant Public Prosecutor and Counsel for accused. I have perused the prosecution records also. On hearing both sides and on perusing the records, I am satisfied that the alleged offences are exclusively triable by Court of Session and the case to be committed to the Hon'ble Sessions Court, Thrissur for trial.

5. Hence the case against the accused is committed to the Hon'ble Sessions Court, Thrissur for trial as provided under section 232 BNSS.

6. Committal of the case shall be notified to the Public Prosecutor, Thrissur.

7. Case records after properly indexing shall be submitted before the Hon'ble Sessions Court, Thrissur.

8. As accused is on bail, he is directed to appear before the Hon'ble Sessions Court on process.
