Court of Sessions, Thrissur.

Order : The case against accused is committed to the  
Hon'ble Court of Sessions, Thrissur for trial U/s. 209  
(a) of Cr.P.C.

**ORDER**

In this case, final report has been filed by Inspector of Police, Kunnankulam Police Station in Crime No. 431/2021 alleging commission of offences punishable under sections 141, 143, 147, 148, 452, 324, 326, 307, 354, 427 r/w 149 of IPC.

2. The prosecution case in brief is that, the accused persons 1 to 5 on 11.4.2021 at 8 pm at Kattakambal desom formed an unlawful assembly, armed with dangerous weapons such as iron rod in furtherance of their common object to commit offence and committed criminal trespass into the house of CW1 and CW2 after broke opening the door of their house and uttered obscene words and also caused criminal intimidation to them. The first and the second accused beat at the head of CW1 with an iron pipe and he sustained injuries at his head. The accused persons inflicted injuries at the right knee, fracture at his left arm and injuries at his forehead. The accused persons destroyed the motor cycle of the CW1 by beating with the iron rod and caused loss of Rs.20,000/-. Thus, the accused persons committed the above mentioned offences.

3. The accused 1 to 4 were granted bail and they executed the same before this Court. Copies of all the relevant prosecution records were furnished to them. Accused 5 is absconding and hence case against him was split up.

4. Upon perusal of the available materials, it is appears to me that, the case of accused is triable exclusively by the Court of Sessions. Therefore, the case against the accused is hereby committed to the Honourable Court of Sessions, Thrissur, u/s 209 (a) of Code of Criminal Procedure.

5. The records and properties, shall be submitted before the Honourable Court of Sessions, as and when called for u/s 209 (c) of Code of Criminal Procedure.

6. The Public Prosecutor, Thrissur shall be notified regarding the committal of the case u/s 209(d) of Code of Criminal Procedure.

7. Accused 5 is absconding and hence case against him is split up and refiled as CP 52/2026.
