ORDER

The Sub Inspector of Police, Vadakkekkad Police Station in crime 562/2025 filed final report against the accused alleging commission of offences punishable under sections 110 of BNS and section 31(1) of Protection of Women from Domestic Violence Act, 2005.

2. Prosecution case in brief is as follows:- The accused, the son of CW1 on 4.8.2025 at 4.30 pm violated the order of this Court in CMP No.5508/2023 in MC 60/2023 filed under the Protection of Women from Domestic Violence Act and entered into the house of

the CW1 and attempted to hit at the head of her husband (CW2) with a *thabook* stone and he evaded that attack timely and when the CW1 tried to prevent the above attack, the accused tried to stab her with three knives. If the CW1 and her husband (CW2) had not evaded the attacks timely, it would have resulted to their death. Thus the accused committed the above mentioned offences.

3. The accused was granted bail by this court and he executed the same before this Court. Copies of all the relevant prosecution records were furnished to him.

4. Upon a perusal of the available materials, it appears to me that, the above case is triable exclusively by a Court of Sessions. Therefore, the case against the accused is hereby committed to Honourable Court of Sessions, Thrissur, u/s 209 (a) of Code of Criminal Procedure.

5. The records and properties, shall be submitted before the Hon'ble Court as and when called for u/s 209 (c) of Code of Criminal Procedure 1973.

6. The Public Prosecutor, Thrissur shall be notified regarding the committal of the case u/s 209(d) of Code of Criminal Procedure.
