ORDER

The present case arose on a final report filed by the Sub Inspector of Police, Cheruthuruthy Police Station in Crime No.618/2023 against the three accused for offences punishable under Section 341, 323 r/w 34 of Indian Penal Code

2. **Prosecution case in brief is as follows:** On 16.10.2023 at about 04.00 pm, noticing that CW2, who is the younger brother of CW1's friend, was being assaulted during an athletic competition held at Attoor Arafa School Ground in connection with the Mulloorkkara Gram Panchayat's Keralotsavam celebrations, CW1 along with his relative CW3, went to intervene and stop the attack. Then the accused persons, in furtherance of their common intention, surrounded them and assaulted them with their hands, causing bodily injuries. The first accused also grabbed and twisted CW1's left hand, causing further harm. Thus, the accused no.1 to 3 committed the offences punishable under Sections 341, 323 r/w 34 of Indian Penal Code.

3. The case was originally filed as CC:1186/2023 before the Hon'ble Judicial First Class Magistrate, Wadakkanchery. The Hon'ble Court took cognizance of the offence, and on finding sufficient grounds for proceeding against the all accused, issued a process for appearance. Subsequently, as per order no. C3-23771/2025 dated 24.09.2025 of Hon'ble Sessions Judge, Thrissur, the above case was transferred to this Court and it was taken on file as CC:15/2023.

4. Upon issuance of summons, the accused no.2 and 3 appeared before this court on 03.02.2026, and were enlarged on bail the same day. Though summons was issued to accused no.1, it was returned unexecuted stating that he is abroad. Copy of all relevant prosecution records was given to the accused no.2 and 3, thus complying with s.230 of BNSS.

5. On perusing the prosecution records it was noted that CW2, who is the injured in this case, is only 16 years old at the time of the incident. Since it was found that the offences alleged are committed against a minor, in view of Section 25 of the Commission for Protection of Child Rights Act, 2005 the case was converted to CP:04/2026. After perusing the prosecution records, I am satisfied that the offences alleged against the accused are exclusively triable by the Court of Sessions (Special Court) and hence, the case against accused no.2 and 3 is committed to the Hon'ble Court of Sessions, Thrissur under Section 362 of BNSS. Case against accused no.1 is split up and refiled as CP:06/2026.

6. Accused no.2 and 3 shall appear before the Hon'ble Court of Sessions, Thrissur as and when directed by the Hon'ble Court of Sessions, Thrissur.

7. The office is directed to send the entire records of this case to the Hon'ble Court of Sessions, Thrissur forthwith, after retaining a copy of the same in CP:06/2026. Notify the commitment of the case to the learned Public Prosecutor, Thrissur.
