

COURT CHARGE IN CC. No. 1757/2023

I, Albin J Thomas, Judicial First Class Magistrate - III, Neyyattinkara hereby charge you, the accused named (7) Santhosh as follows:-

Firstly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, were a member of an unlawful assembly, in prosecution of the common object and thereby you have committed the offence punishable u/s. 143 r/w 149 of IPC and within the cognizance of this Court.

Secondly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in prosecution of the common object, committed rioting and thereby you have committed the offence punishable u/s. 147 r/w 149 of IPC and within the cognizance of this Court.

Thirdly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in prosecution of the common object and armed with deadly weapons and thereby you have committed the offence punishable u/s. 148 r/w 149 of IPC and within the cognizance of this Court.

Thirdly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, trespassed into the house of CW1 (Sureshkumar) and thereby you have committed the offence punishable u/s. 452 of IPC and within the cognizance of this Court.

Fourthly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in furtherance of common object had voluntarily caused hurt to CW1 (Sureshkumar) and thereby you have committed the offence punishable u/s. 323 of IPC and within the cognizance of this Court.

Fifthly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in furtherance of common object had voluntarily caused

hurt to CW1 (Sureshkumar) with dangerous weapon and thereby you have committed the offence punishable u/s. 324 of IPC and within the cognizance of this Court.

Sixthly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in furtherance of common object had voluntarily caused grievous hurt to CW1 (Sureshkumar) with dangerous weapon and thereby you have committed the offence punishable u/s. 326 of IPC and within the cognizance of this Court.

Seventhly, that you, on 06.03.2003 at 08.00 pm at Kallambalam in Athiyannoor Village, in furtherance of common object had criminally intimidated CW1 (Sureshkumar) and thereby you have committed the offence punishable u/s. 506(ii) of IPC and within the cognizance of this Court.

And I, hereby direct that you be tried by this Court on the said charges.
