This Suit having been finally heard on 12/03/2026 and the court on the same day delivered the following :-

### **JUDGMENT**

Plaintiff represented. Defendant 1 and 2 represented. Plaintiff has not remitted balance court fee. IA 2/2026 filed by the plaintiff, seeking time for remitting balance court fee, is dismissed. As sufficient opportunity was given to the plaintiff for remitting balance court fee and as no medical records are produced disclosing that due to medical grounds the plaintiff is unable to arrange money for remitting balance court fee, I am not inclined to grant any further time for remitting balance court fee. Thus the suit is rejected under order 7 Rule 11(c) of the Code of Civil Procedure, 1908. As the Suit is rejected for non-payment of balance court fee, the order of
