This CMP has been heard on today and this court passed the following:

ORDER

This is an application filed under section 23(2) of the Protection of Women from Domestic Violence Act, 2005.

2. Heard the petitioners. On perusal of the affidavit and other allegations made in the application, I find that there is a prima facie case of commission of domestic violence by the respondent against the petitioners. The petitioners apprehend that the respondent would commit domestic violence against them. If notice is ordered, it may defeat the very purpose of the application. I find that the petitioners are entitled for an interim order without notice to prevent further incidents of domestic violence against them. Hence the following interim relief is granted in favour of the petitioners until further orders.

1. The respondent is restrained from committing any sort of mental or

physical violence against the petitioners.

2. The respondent is restrained from dispossessing or in any other manner disturbing the possession of the petitioners in the shared household namely, Riyas Manzil, Mannamvilakam, Vembayam, Kuthirakulam P.O, Manikkal Village, Nedumangad.

3. The respondent is restrained from entering into the shared household namely, Riyas Manzil, Mannamvilakam, Vembayam, Kuthirakulam P.O, Manikkal Village, Nedumangad.

3. Issue notice to the respondent. Issue copy of the order to both parties and SHO concerned free of costs.

4. SHO, Venjaramoodu is directed to provide every assistance to the petitioner for implementation of the order.
