**ORDER**

Petitioners absent. Represented. The court heard and perused the records. After considering the materials, I am satisfied that the petitioner has made out a prima facie case. So I am of the further view that ad-interim protection order can be granted. Other reliefs, if any, can be considered after the appearance of the respondents. Hence ad-interim protection order is granted and respondents are hereby restrained from:

- (i) committing any act of physical or mental abuse and from doing any act of domestic violence against the petitioners.
- (ii) entering or disturbing the first petitioner at her work place.
- (iii) contacting the petitioners, either directly or through telephonic or any other electronic means.

(iv)entering into Thiruvonam,MMRA 150(1),Chamavila lane,Melathumele, Manikanteswaram.P.O.Thiruvananthapuram,where the petitioners are now residing until further orders.

Office is directed to comply Sec.24 of the Protection of Women from Domestic Violence Act. Issue order and notice to the respondents. For return of notice on 6.6.2026. Communicate the order to S.H.O., concerned.
