This petition coming on for hearing on 23rd September, 2023 and the court on the same day passed the following.

ORDER

Heard.

2. This is an application for reviewing order dated 4.8.2023 in I.A.no. 2/2021 by which I dismissed the said application.

3. I.A.no.2/2021 was filed for sending documents to FSL for getting report of expert. I directed to forward the records on 8.11.2021 as per order in the said IA.

4. Till 4/8/2023, the petitioner did not take steps to forward the records. So, I reviewed the above said order and dismissed I.A. 2/2021.

5. This petition is filed for reviewing the said order on the ground that the petitioner could not take steps as he was not well. No supporting documents to prove illness of petitioner is produced. Moreover, the petitioner has not yet produced envelope to forward records (register (4 nos)) to FSL.

6. So I don't find any bonafides on the part of petitioner. The conduct of the petitioner who is the defendant in the suit shows that he intends to delay disposal of this suit.

Having regard to the above said facts, I am of the opinion that there is no ground for review order dtd. 4.8.2023 in I.A. 2/2021. So this petition is dismissed.
