Relief:

The Original Suit is filed on 30.09.2023 for realisation of a sum of Rs.10,21,999/- (Rupees Ten Lakh Twenty One Thousand Nine Hundred and Ninety Nine only) with interest @ 12% from the date of suit till realisation and allow all costs and such other reliefs from defendant and his assets.

Cause of action:

The cause of action for this suit has arisen on 15.06.2023, and 18.09.2023 and continuously thereafter at Attingal Village which is within the jurisdiction of this Hon'ble court.

Valuation and Court Fee:

The suit is valued at Rs.10,21,999/- (Rupees Ten Lakh Twenty One Thousand Nine Hundred and Ninety Nine only) for which a court fee of Rs.100159.92/- (Rupees One Lakh One Hundred and Fifty Nine and Paise Ninety Two only) is levied under section 22 of the Kerala Court Fees and Suit Valuation Act and paid Rs.1,00,322/-. Legal benefit fee of Rs.10,220/- (Rupees Ten Thousand Two Hundred and Twenty only) is levied and paid.

This suit is coming on for hearing on 02.03.2026, the court examined PW1 and Exhibits A1 & A2 were marked from the side of Plaintiff and the defendant is set exparte and on 12.03.2026 the court doth Order and Decree as follows:

The suit is decreed with costs as follows: -

The plaintiff is entitled to realise Rs.10,00,000/- (Rupees Ten Lakh only) with interest @ 6% per annum from the date of cheque (20-07-2023) till realisation.
