This case coming up for hearing today, this Court passed the following:

ORDER

This is the order in an application filed U/s. 23 (2) of the Protection of Women from Domestic Violence Act, 2005.

Petitioner is present. Heard Counsel for the petitioner. Perused records. This court is prima facie satisfied that there is domestic relationship between the parties and that if an exparte protection order is not granted, the petitioner would suffer irreparable loss. Hence this petition is allowed and interim order is passed as follows:-

1. Respondent is restrained from causing any physical or mental harassment to the petitioner as envisaged U/s. 18 of PWDV Act.
2. Respondent is restrained from forcefully dispossessing or disturbing the residence of the petitioners at Sanjeevini Apartment, 2nd Floor, House No. 4, Chanthavila, Pothencode P O, Thiruvananthapuram.
3. Respondent is restrained from entering the work place of the 1st petitioner at LPS Pothencode, Chilanka Dance class, and the School at which the 2nd petitioner studies, Magic Planet, Different Art Centre, KINFRA Film Park, Chanthavila.
4. Copy of this order shall be communicated to SHO, Pothencode, who is directed to provide necessary assistance to the petitioner in implementation of this order.
5. The other reliefs shall be considered after the appearance of counter petitioner.
