**JUDGMENT**

This is a case in which final report has been filed by Sub Inspector of  
Police, Mangalapuram Police Station in Crime No.180/2014 against the

accused alleging commission of offences punishable U/S. 294(b) & 506(ii) of Indian Penal Code 1860.

2. The prosecution case in brief is as follows:-The accused due to his prior enmity towards the informant uttered obscene words towards him and criminally intimidated him by showing a knife at Bharat Petroleum, Veiloor on 23/02/14 at 10.40 pm. Thus the accused committed the offences alleged.

3. Originally, the case was taken on file as CC 274/2014 and later it was transferred to LP Register as LP 08/2025. On appearance of accused, his case is refiled as the present case and he was released on bail. Copies of all relevant prosecution records were furnished to him u/s. 207 Cr.PC. Particulars of offences punishable u/s.294(b) & 506(ii) of Indian Penal Code 1860 were read over and explained to the accused who is facing trial, to which he pleaded not guilty and claims to be tried.

4. On the side of the prosecution CW1 to CW10 were cited and PW1 was examined and Ext.P1 marked. CW2 to CW10 were given up by the learned APP. The informant turned hostile to the prosecution, there is no purpose in continuing with the prosecution evidence. Thus the prosecution evidence closed. Since there are no incriminating circumstances brought out against the accused from the prosecution evidence, examination of him u/s.313(1)(b) Cr.P.C. was dispensed with. No defence evidence was adduced.

5. Heard both sides.

6. The points that arose for consideration are:-

1) Has the accused uttered obscene words towards the informant and criminally intimidated him by showing a knife at Bharat Petroleum, Veiloor on 23/02/14 at 10.40 pm and thereby committed the offence punishable u/s. 294(b) & 506(ii) of IPC ?

2) Sentence or Order?

7. **Points No. 1** :-

PW1, the informant turned hostile to the prosecution stating that he did not know who committed the offence. The statement she gave to police marked as Ext.P1. Since he failed to identify accused, there exists no evidence against him.

8. **Point No. 2** :-

In light of the findings in point No. 1, I am of the view that the prosecution has failed to prove that the accused committed the offences alleged against him.

**In the result**, the accused is found not guilty for the offences punishable U/S. 294(b) & 506(ii) of Indian Penal Code 1860 and he is acquitted of the said offences u/s. 255(1) Cr.P.C. His bail bond stands cancelled and he is set at liberty.
