U/s.232(a) of BNSS.

**ORDER**

1. This case arose from the final report filed by the the Excise Inspector of Police, Kattakada Excise Range Office in crime no. 35/2025 against the accused alleging offence punishable Under S. 55 (i) of Kerala Abkari Act I of 1077.
2. Prosecution case in brief is that 11.15 am on 18.04.2025 at Kalluvarambi, CW1 and his party found accused in possession of 3.5 liters of Indian Made Foreign Liquor for the purpose of sale and recovered Rs. 1000/- from him as sales proceeds. Hence the accused is alleged to have committed the aforesaid offences.
3. The Hon'ble Sessions Court, Thiruvananthapuram granted him bail as per Crl.MC no. 1221/2025 dated 07.05.2025. Copies of all relevant prosecution

records were given to the accused and thereby mandate u/s. 230 of BNSS was complied with.

4. Heard the learned APP and the learned counsel for the accused. Perused relevant records.
5. On perusal of the records it is found that the offences alleged against the accused is exclusively triable by the Hon'ble Court of Sessions. Therefore, the case against accused is hereby committed to the Hon'ble Court of Sessions, Thiruvananthapuram as per U/s.232(a) BNSS.
6. The case records, documents, material objects if any shall be forwarded to Hon'ble Sessions Court, Thiruvananthapuram in compliance to S. 232(c) BNSS and Rule 77(2) of Criminal Rules of Practice, Kerala.
7. Intimate the committal of this case to learned public prosecutor under S.232(d) of BNSS.
8. The accused is directed to appear before the Hon'ble Sessions Court, Thiruvananthapuram as and when required.
9. The office is directed to keep certified copies of all relevant records before sending the case records to the Hon'ble Court of Sessions.
