This is a petition filed by the learned Special Public Prosecutor seeking permission to collect the blood sample of the survivor and her child.

This petition coming on this day for hearing before me in the presence of Sri.T.G.Mohandas, Special Public Prosecutor for the Petitioner/State and upon perusing the petition, Court passed the following:

ORDER

This is a petition filed by the learned Special Public Prosecutor seeking permission to collect the blood sample of the survivor and her child born on 29.04.2026 at the Medical College Hospital, Mananthavady for forwarding the same for DNA analysis and to stop the further proceedings in the case for the above purpose.

2. The charge sheet in this case was filed on 12.04.2026 and taken

on file as SC 52/2026 u/ss. 64(2)(m) and 332(b) BNS, Sec. 5(j)(ii) & (l) r/w 6(1) of the Protection of Children from Sexual Offences Act, 2012.

3. The allegation in this case is that the accused had been in a romantic relationship with the defacto complainant, aged 16 years, residing along with her family at Palakkoly in Pulpally Amsom, for about three years, and from 08.07.2025 at 22.00 hours onwards for one week he had repeatedly committed rape/penetrative sexual assault upon her from the bedroom of his house bearing door No. II/518 of Pulpally Grama Panchayat situated at Veettimoola Unnathy, and thereafter, he had again repeatedly committed rape/penetrative sexual assault upon her till 25.10.2025 at about 22.00 hours, from her house bearing door No. 3/29 of Pulpally Grama Panchayat situated at Palakkolly Unnathy after trespassing into her house when no one was in her house.

4. The records reveal that the survivor had given birth to a baby subsequent to the filing of the charge sheet. Considering the facts and circumstance of the case, I am of the view that permission has to be granted to collect the blood sample of the survivor and her child for conducting DNA analysis.

In the result, CrI.M.P 02/2026 stands allowed.
