This case referred to this Lok Adalath U/S 19 of Legal Services Authorities Act 1987 (Act 39/87), coming on before us for endeavors for settlement of dispute between parties being the subject matter of this case, in the presence of the parties and their counsel, and a full and frank discussion of all issue factual and legal arising from the cause, the parties having agreed before us that there shall be an award/order/decree in terms of settlement hereto made and the parties/their counsel herein having, in acceptance of the same signed in our presence, it is decreed/ordered the following.

AWARD

1. The insurer above mentioned shall pay an amount of **₹2,70,000/- (Rupees Two lakh and seventy thousand only)** to the petitioner within one month from today, in default the amount shall bear interest @ 8% per annum from this date as described below:
2. Insurer shall deposit the award amount directly to the bank account to the petitioner by way of electronic transfer.
3. Full court fee paid shall be refunded to the petitioner.
4. Petitioner/Claimant/guardian is directed to produce attested copy of Bank Pass Book. Respondent No.3 shall comply the award as stated above after furnishing bank account of the claimant.
5. Respondent No.3 shall file a statement regarding the compliance of the order before this Tribunal along with certificate of transaction by way of NEFT attested by the Bank concerned.
