MEDIATION AGREEMENT

- I. The insurer above mentioned shall pay an amount **₹35,000/-(Rupees Thirty five thousand only)** to the petitioner within one month from today, in default the amount shall bear interest @ 8% per annum from this date as described below:
- II. Insurer shall deposit the award amount directly to the bank account to the petitioner by way of electronic transfer and the petitioner is entitled to withdraw the amount as and when he required.

III. Full court fee paid shall be refunded to the petitioner.

IV. Petitioner/Claimant/guardian is directed to produce attested copy of Bank Pass Book. Respondent No.3 shall comply the award as stated above after furnishing bank account of the claimant.

V. Respondent No.3 shall file a statement regarding the compliance of the order before this Tribunal along with certificate of transaction by way of NEFT attested by the Bank concerned.

2. In view of the afore said agreement entered in to between parties, the parties pray that the Suit/Appeal/Petition/Complaint be disposed of in terms of the aforesaid agreement.

3. In view of the aforesaid agreement, Plaintiff/Appellant/Petitioner prays for refund of full institution fee.

4. Parties will appear on 11.03.2026 before the court for passing Orders/Decree in terms of the above agreement.
