DECREE

- i. The defendant is directed to pay to the Plaintiff Bank a sum of ₹6,05,751/- (Rupees six lakh five thousand seven hundred and fifty one only) with interest @ 9% per annum from the date of the suit till the date of decree and thereafter with interest @ 6% per annum till realization of the amount. The amount shall be paid within one year from the date of decree.*
- ii. The defendant is directed to pay the costs of the suit to the plaintiff.*
- iii The defendant do pay an amount of Rs. 90,126/- to the Plaintiff being the costs of the suit.*
