C O M M I T T A L O R D E R

This is a case instituted on a report by the Sub Inspector, Thalapuzha in Crime No.705/2025, alleging commission of offences punishable under sections 75(1)(ii), 75(2), 78(1)(ii) and 78(2) of BNS and under section 120(o) of the Kerala Police Act.

2. The prosecution allegation is that the accused from 01.09.2025 to 16.09.2025, sent obscene messages to the mobile phone number 9747975609 used by the victim, through Whats app from his mobile phone number 9526626393 despite her disinterest and thereafter, on 16.09.2025 at 10.45 am in front of M/s.Seeco Pappada Unit at Thalapuzha Chungam, he grabbed her hand with sexual intent and asked her for sexual favours and on 08.11.2025 at 23.00 hours he sent obscene message to her husband's mobile phone number 9961134797 through Facebook Messenger and despite her disinterest he constantly harassed her through electronic media and directly. Thus the accused is alleged

to have committed the offence punishable under sections 75(1)(ii), 75(2), 78(1)(ii) and 78(2) of the Bharatiya Nyaya Sanhita and under section 120(o) of the Kerala Police Act.

3. On perusal of records, it is seen that the offence alleged against the accused is exclusively triable by the Honourable Court of Sessions. Hence, the case was taken on file as C.P.2/2026. Thereafter, the accused entered appearance and he was enlarged on bail. The copies of all the relevant prosecution records were given to him in compliance with section 230 of the Bhartiya Nagrik Suraksha Sanhita.

4. Hence I commit this case to the Honourable Court of Sessions, Kalpetta Division, under Section 232(a) of the Bhartiya Nagrik Suraksha Sanhita. The accused who is bail is hereby directed to appear before the Honourable Court of Sessions, Kalpetta as and when directed to do so by the Honourable Court of Sessions.

5. The entire case records be submitted to the Honourable Court of Sessions, Kalpetta forthwith. Notice of committal shall be given to the learned Public Prosecutor, Kalpetta in compliance of section 232(d) of the Bhartiya Nagrik Suraksha Sanhita.
