

Order below Exh.1 in Criminal (Tr.) M.A. No.154/2025:

(Sau. Lata Navnath Gole Vs. M/s. J.M. Industries and anr.)

It is an application under Section 448 of the Bhartiya Nagarik Suraksha Sanhita (BNSS), 2023, for transfer of files in one Court.

2) It is contended by the applicant that non-applicant no.1 M/s. J.M. Industries, a partnership firm, has filed in all seven complaints under Section 138 of the Negotiable Instruments Act, 1881, bearing Nos. **SCC 6905/2019, 6906/2019, 6907/2019, 6814/2019, 6903/2019, 6902/2019** and **6904/2019**, against the company of the applicant i.e. Ishkrupa Shipping and Logistics Pvt. Ltd., Mr. Navnath Gole, are the Directors of the said company. All these cases are arising out of one transaction, parties are the same and the defence is also same. However, these cases are pending in different Courts as mentioned in the Schedule. Therefore, in order to avoid contradictory orders and for the sake of convenience of the parties, it is just and necessary to try all the cases before one Court.

3) The applicant, in support, has produced on record, copy of Exh.1 of all the complaints for perusal and also filed an affidavit in support.

4) The non-applicant no.1 is duly served, but remained absent. Hence, the application proceeded ex-parte against it. Non-applicant no.2 is a formal party.

5) Heard the learned advocate of the applicant. Perused the documents filed on record.

6) After going through the contents of the complaints and the affidavit filed by the applicant, it appears to me that in all the cases, parties are same, the cause of action also appears to be the

same and therefore, these cases are to be decided by one Court to avoid contradictory orders. Even, for the convenience of the parties, it is just and necessary to transfer these cases to one Court. In view of this, the following order is passed.

ORDER

- 1) **Criminal M.A. No. 154/2025**, is hereby allowed.
- 2) **S.C.C. No.6906/2019, S.C.C. No.6907/2019 and S.C.C. No.6814/2019** pending in the Court of Additional Chief Judicial Magistrate (Court No.5), Ahmednagar, **S.C.C. No.6902/2019** pending in the Court of Additional Chief Judicial Magistrate (Court No.6) and **SCC No.6904/2019** pending in the Court of Additional Chief Judicial Magistrate (Court No.10), Ahmednagar, are hereby withdrawn and transferred to the Court of Joint Civil Judge, Senior Division and Additional Chief Judicial Magistrate, Ahmednagar, where **SCC No.6903 and 6905/2019**, are pending, for hearing and disposal in accordance with law.
- 3) Copy of this order be sent to the concerned Courts for compliance.
- 4) No order as to costs.
