**Examination-in-chief by Smt. Seema Shaikh for prosecution :-**

1. My educational qualification is MBBS Diploma in anesthesia. I am working as Medical Officer at Civil Hospital, Ahmednagar since 2020. I was working as casualty medical officer on 06/09/2021. On that day Patient Sangita Ulhas Thokal and Swati Satish Vairal visited Civil Hospital with police yadi. Swati Satish Vairal narrated history of physical assault on 06/09 /2021 at 08.00 pm. I examined her at 09.10 pm. Identification mark- mole over right mandibular region

I found following injuries on her person :-

I. CLW laceration over vertex of scalp of 3 cm x 0.5 cm

2. Injury may be caused by hard blunt object. Age of injury is within 24 hours. Nature of the injury is simple. Now, medical certificate is shown to me. It bears my signature. It is in my hand writing. Its contents are true and correct. It is marked **Exh. 16.**

3. Sangita Ulhas Thokal, 50 years old, R/o Nimblak narrated history of physical assault on 06/09/2021 at 08.00 pm. I examined her at 09.00 pm. Identification mark- mole over lateral side of left eye.

I found following injuries on her person :-

- I. CLW laceration over left temporal region of size 6 x 0.5 cm
- II. Laceration over the forehead just above the right eye of size 01 x 0.2 cm.

4. Both injuries may be caused by hard blunt object. Age of injuries is within 24 hours. Nature of the injuries is simple. Now, medical certificate is shown to me. It bears my signature. It is in my hand writing. Its contents are true and correct. It is marked **Exh. 17.**

Examination-in-chief is over.

**Cross-examination by Advocate Shri.R. P. Shelot for the accused:-**

5. It is not true to say that injuries of both the patients can be caused due to fall on rough surface or fall on wire fencing. On that day my duty hours were 9.00 p.m. to 9.00 a.m. of next day.

6. On that day I examined patient namely Satish Bhagwan Vairal. His injury was abrasion. He came with police yadi and brought by his relatives. It is not true to say that injuries of both the above said patients can be caused while entering house and dashed to iron door. It is true to say that such types of injuries can be caused due to wooden stick.

Que:- Such injuries can be caused due to forceful assault by iron rod

Ans:- It is not true.

7. The stitches were given to both the patients. The patients were not admitted in the hospital. In medical certificate Exh. 16 and 17 not mentioned about stitches.

8. It is true to say that the police has not made inquiry in respect of Satish Bhagwan Vairal and not demanded his medical certificate. It is not true to say that the injuries of both the patients were caused due to fall on rough surface, but I have not mentioned the same in certificate deliberately. It is not true to say that I deposed false.

Cross examination is over.
