**Examination-in-chief by Smt. Seema Shaikh for prosecution :-**

1. My educational qualification is MBBS Diploma in orthopedic. I am working in my Bhairavnath Hospital, Ahmednagar. Since 2019-2020 I am working there. On 07/09/2021 patient Mrs. Sangita Ulhas Thokal, 50 yrs., and Mrs. Swati Satish Vairal, 27 yrs., visited at my hospital. Both patients were having injuries on their head. I have examined Sangita Ulhas Thokal. I found following injuries on her person :-

I. CLW over head and right eyebrow. She was having 16 stitches on her head.

2. I have admitted her for further treatment. Injuries were simple in nature. At the time of discharge I have issued medical certificate. Now, medical certificate is shown to me is the same. It bears my signature. It is in my hand writing. Its contents are true and correct. It is marked **Exh. 29.**

3. Then I have examined Swati Satish Vairal, 27 yrs., I have examined her and found following injury on her person :-

I. CLW over head. She was having 7 stitches. I have admitted her for further treatment. At the time of discharge I have issued medical certificate. Now, medical certificate is shown to me is the same. It bears my signature. It is in my hand writing. Its contents are true and correct. It is marked **Exh. 30.**

Examination-in-chief is over.

**Cross-examination by Advocate Shri. R. P Shelot for the accused:-**

4. It is true to say that the case of patients was MLC case. I have not informed to the police. The patients have already taken treatment at Civil Hospital, Ahmednagar. They have given treatment on OPD basis. It is true to say that I have not gone through the papers of previous treatment.

5. The patients have narrated me the history of incident. Both patients were

admitted in my hospital for five days. It is true to say that the date of admission and discharge, age of injuries and object of injuries are not mentioned in medical certificate Exh. 29 and 30. Police did not demand me said medical certificates. It is not true to say that both patients are residents of my area. It is true to say that medical certificate Exh. 29 and 30 are not in the medico legal format. It is true to say that these certificates are formal. It is true to say that I have not given documents of admission to the patients. It is not true to say that since the patients are acquainted with me I have admitted them for five days without any necessity and given this false certificate. It is not true to say that I deposed false.
