**Order passed below Exh. 208 on solemn affirmation
Re-Examination by Smt. Seema Shaikh for prosecution.**

1) On 03/06/2016, when patient Milind Jape came to our hospital he was examined by me, physician Dr. Kabadiya, orthopedic surgeon Dr. Vilas Vyavhare and Neuro surgeon Dr. Majid and advised necessary investigations. The patient was advised X-ray of hand and C.T. scan of brain. X-ray hand shows third proximal phalanx and fracture of second metacarpi phalangeal joint fracture of left hand. The nature of injury was grievous. Therefore, surgery was carried out on 04/06/2016 by Dr. Vilas Vyavhare and patient was discharged on 07/06/2016. Accordingly, certificate was issued by Dr. Vilas Vyavhare. The certificate bears his signature. He was my colleague, therefore, I know handwriting and signature.

2) It is true to say that for the purpose of X-ray and C.T. scan there is separate technician in the hospital. The surgery was done by orthopedic surgeon Dr. Vilas Vyavhare. It is not true to say that I have not given any treatment to the patient. It is true to say that I have not prepared MLC report of the patient. Witness volunteers that it is prepared by R.M.O. It is true to say that patient

Milind Jape did not narrate me cause of injury caused to him. It is not true to say that I have stated incorrect information in my re-examination.
