1. Date of commission of offence : 30.09.2023
2. Date of report/complaint : 02.10.2023
3. Name of the complainant : State of Maharashtra, through PSO, Nagar Taluka Police Station, Ahmednagar.
4. Name, age and residence of the accused : Sarabatsingh Harchandsingh, Age: 33 years, Occ. - Transport, R/o. C/o. G.E. Road, Tatibandh Raipur, Chatisgad, Dist. Chatisgad, State- Chatisgad.
5. Particulars of Offence :

**FIRSTLY**, that on dated 30.09.2023, at about 05-00 p.m., on Nagar-Pune road, in *Chas Ghat*, in the vicinity of village Chas, Tq. & District -Ahmednagar, you drove Truck bearing its registration No. CG-04-HY-3049 in a manner so rashly or negligently as to endanger human life or public safety of others, and thereby, you have committed an offence punishable under Section 279 of the I.P.C., and within my cognizance.

**SECONDLY**, on aforesaid date, time & place, you caused hurt to Umesh Ratnaparkhi by driving aforesaid Truck so rashly or

negligently as to endanger human life or personal safety of others, and thereby, you have committed an offence punishable under Section 337 of the I.P.C., and within my cognizance.

**THIRDLY**, on aforesaid date, time & place, you caused grievous hurt to the informant & her sons namely Atharva & Arnav by driving aforesaid Truck so rashly or negligently as to endanger human life or personal safety of others & thereby, you have committed an offence punishable under Section 338 of the I.P.C., and within my cognizance.

**FOURTHLY**, on aforesaid date, time & place, you failed to report the accident to the nearest police station & to provide medical aid to the injured persons, and thereby, you have committed an offence punishable under Section 177 r/w. Section 134 (a) & (b) of the M.V.Act, and within my cognizance.

**FIFTHLY**, on aforesaid date, time & place, you were found driving the aforesaid Truck at a speed or in a manner which was dangerous to the public having regard to the circumstances of the case, and thereby, you have committed an offence punishable under Section 184 of the M.V.Act, and within my cognizance.

**LASTLY**, on the aforesaid date, time & place, you committed mischief by means of wrongful loss to the Car bearing its

registration No.MH-14-JM-2681, and thereby, you have committed an offence punishable under Section 427 of the I.P.C., and within my cognizance.
