CHARGE

I, L. S. Padhen, Chief Judicial Magistrate, Ahmednagar do hereby charge you accused,

1. Sumit Santosh Varma
Age: 34 Yrs.,
R/o.: Manik Nagar, Railway Station Road,
Tal. Nagar, Dist. Ahilyanagar.
2. Amol @ Ambernath Tukaram Bhalsing
Age: 29 Yrs.,
R/o.: Nagar Daund Road, Kedgaon,
Tal. Nagar, Dist. Ahilyanagar.
3. Aniket Santosh Shiyal
Age: 25 Yrs.,
R/o.: Shivaji Nagar, Kalyan Road,
Tal. Nagar, Dist. Ahilyanagar.
4. Prakash Lahu Gaikwad
Age: 29 Yrs.,
R/o.: Darewadi, Tal. Nagar, Dist. Ahilyanagar.

As follows :

That you accused along with 3 to 4 unknown persons on 27/09/2024 at about 03.26 p.m. in front of Indrayani Hotel, Nagar Aurangabad Road, Ahilyanagar and at about 4.00 p.m. at Maharashtra Navnirman Office, Delhi gate, Ahilyanagar were members of unlawful assembly and in prosecution of common object of the said assembly, voluntarily caused hurt to the informant by wooden stick on his waist and rib and thereby committed an offence punishable under **Section 118(1)** read with Section 190 of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

Secondly, that you accused along with 3 to 4 unknown persons,

on the aforesaid date, time and place, were members of unlawful assembly and in prosecution of common object of the said assembly, voluntarily caused hurt to informant by fist and kick blows and thereby committed an offence punishable under **Section 115(2)** read with Section 190 of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

Thirdly, that you accused along with 3 to 4 unknown persons, on the aforesaid date, time and place, were members of unlawful assembly, the common object of which was to create fear and thereby committed an offence punishable under **Section 189(2)** read with Section 190 of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

Fourthly, that you accused along with 3 to 4 unknown persons, on the aforesaid date, time and place, were members of unlawful assembly and in prosecution of common object of the said assembly intentionally insulted the informant by abusing him and gave provocation to him, knowing it to be likely that such provocation will cause him to break Public peace and thereby committed an offence punishable under **Section 352** read with Section 190 of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

Fifthly, that you accused along with 3 to 4 unknown persons on the aforesaid date, time and place, were members of unlawful assembly and in prosecution of common object of the said assembly, committed criminal intimidation by threatening the informant with injury to his person with intent to cause alarm to him or to cause him do any act to which he is not legally bound to do and thereby committed an offence punishable under **Section 351(2)(3)** read with Section 190 of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

Lastly, that you accused along with 3 to 4 unknown persons, on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, knowing reason to believe that an offence has been committed, causes evidence of the commission of that offence to disappear, with the intention of screening the offender from legal punishment and thereby committed an offence punishable

under **Section 238** read with Section 3(5) of the Bharatiya Nyaya Sanhita 2023 and within my cognizance.

And I hereby direct that you be tried by this Court for the aforesaid charges.
