As follows :

That, you accused on 16/11/2020 at about 20.30 p.m. at Vanjar Lane, Govind Garage, Dhapasewada, Ahmednagar were members of unlawful assembly, the common object of which was to create fear and you have thereby committed an offence punishable under **Section 143** of the Indian Penal Code and within my cognizance.

Secondly, that you accused on the aforesaid date, time and place, were members of unlawful assembly and in prosecution of common object of the said assembly committed an offence of rioting and you have thereby committed an offence punishable under **Section 147** of the Indian Penal Code and within my cognizance.

Thirdly, that you accused on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, voluntarily caused hurt to the informant by fist and kick blows and thereby you have committed an offence punishable under **Section 323 read with Section 149** of the Indian Penal Code and within my cognizance.

Fourthly, that you accused on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, caused hurt to informant and prosecution witness by pelted stones on door, kitchen appliances and mixer to the side of informant which caused injury to the public so rashly or negligently as to endanger human life or personal safety and thereby committed an offence punishable under **Section 337 read with Section 149** of the Indian Penal Code and within my cognizance.

Lastly, that you accused on the aforesaid date, time and place, were the members of unlawful assembly, committed mischief by causing wrongful loss to the informant by damaging mixer and kitchen appliances and to the amount more than Rs.50/- owned by the informant and thereby committed an offence punishable under **Section 427 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court for the aforesaid charges.
