Thereafter, the complainant had issued the legal notice u.s.138(b) of the N.I.Act dated to you for demanding the cheque amount. You received the said notice, however, failed to repay an amount mentioned in cheque to the complainant within stipulated period and thereby you have committed an offence punishable under **section 138** of the Negotiable Instruments Act, 1881 and within my cognizance.
