**Examination-in-chief by A.P.P. Mr. Thakur**

1. I am MBBS & MS. In the year 2019, I did complete MS. On dated 02.07.2021, I was working in Casualty Department of the Civil Hospital, Ahmednagar. On that day, I was on duty since 09.00 p.m. to 09.00 a.m. On that day, at about 10.30 p.m., one patient by name Gorakh s/o. Popat Borude came to the Hospital. He had narrated history of physical assault at about 03.30 p.m. on the same day. I got the said patient medically examined. Upon his medical examination, following injuries were found on his person-

i. abrasion over left parietal region, size 2 x 2 c.m.,

2. After his medical examination, CT scan of the patient was taken & accordingly, the report to the effect that no significant neuroparenchymal abnormality was found. Aforesaid injury was simple in nature. The aforesaid injury was within 6 to 8 hours. Aforesaid injury could be possible by hard & blunt object, like iron rod. Later on, I issued the injury certificate to the Police. The said certificate now shown to me. Contents thereof are true & correct. It bears my signature & seal of Civil Hospital, Ahmednagar. It is marked as **Exh.32**. Now, I am showing an iron rod '**Article-A**'. The aforesaid injury is possible due to an assault made by the said rod. Before examining the said patient, I had examined number of such patients.

**Cross examination for accused by Adv. Mr. Gore**

3. On dated 02.07.2021, I had examined 20 to 25 patients approximately. On that day, besides myself, 4 to 5 staff members were present along with me. It is true to say that the patient was treated as O.P.D. patient. It is not true to say that history of the patient was narrated to me by his relatives. It is true to say that while narrating history, I was not told by the patient the name of the object by which he was allegedly assaulted. It is true to say that the column of address appearing on the injury certificate Exh.32 is not filled. It is true to say that the column of identification of marks appearing on the injury certificate Exh.32 is also not filled.

4. It is true to say that the column of age of injury appearing on the injury certificate Exh.32 is also not filled. It is true to say that the aforesaid injury can be possible if someone falls from the platform. It is not true to say that the injury certificate has been prepared by me at the say of the informant. It is not true to say that I have deposed falsely in order to assist the informant.
