As follows :

That, you accused on 22/05/2024 at 01.00 p.m. near Datt Temple, in front of HDFC Bank, Sukhakarta corner, Pipe line Road, Ahmednagar, were members of unlawful assembly, the common object of which was to create fear and thereby committed an offence punishable under **Section 143** of Indian Penal Code and within my cognizance.

**Secondly**, that you accused, on the aforesaid date, time and place, were members of unlawful assembly and in prosecution of common object of the said assembly committed an offence of rioting and thereby committed an

offence punishable under **Section 147** of Indian Penal Code and within my cognizance.

**Thirdly**, that you accused on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, voluntarily caused hurt to the informant by iron sickle and wooden stick and offence is likely to cause death of informant and thereby committed an offence punishable under **Section 324 read with Section 149** of the Indian Penal Code and within my cognizance.

**Fourthly**, that you accused on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, caused hurt to the informant by fist and blow and thereby committed an offence punishable under **Section 323 read with Section 149** of the Indian Penal Code and within my cognizance.

**Fifthly**, that you accused on the aforesaid date, time and place, were the members of unlawful assembly and in prosecution of the common object of that assembly, intentionally insulted the informant by abusing him and gave provocation to him, knowing it to be likely that such provocation will cause him to break Public peace and thereby committed an offence punishable under **Section 504 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this Court for the aforesaid charges.
