CHARGE

I, Shri. L. S. Padhen, Chief Judicial Magistrate, Ahmednagar do hereby charge you accused,

1. Nandu @ Shirish Shantaram Jadhav
Age: 53 Yrs.,
2. Pravin Thakshen Salve
Age: 25 Yrs.,
3. Vrushal Sunil Salve
Age: 30 Yrs.,
Accused Nos. 1 to 3 R/o.: Gautam Nagar,
near Rubab Showroom, Balikashram Road,
Ahmednagar.
4. Pappu @ Abhijit Avinash Jadhav
Age: 30 Yrs.,
R/o.: Wadgaon Amali, Tal. Parner, Dist. Ahmednagar

As follows :

That you accused on 16/08/2024 at evening at about 05.00 p.m. in front of Rubab Showroom, Savedi, Ahmednagar, in furtherance of your common intention, voluntarily caused hurt to the informant by wooden stick on his right hand and thereby committed an offence punishable under **Section 118(1) read with Section 3(5) of the Bharatiya Nyaya Sanhita 2023** and within my cognizance.

Secondly, that you accused, on the aforesaid date, time and place, in furtherance of your common intention, voluntarily caused hurt to the informant by fist and kick blows and thereby committed an offence punishable under **Section 115(2) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023** and within my cognizance.

Thirdly, that you accused, on the aforesaid date, time and place, in furtherance of your common intention, intentionally insulted the informant by abusing him and thereby gave provocation to him intending or knowing it to be

likely that, such provocation will cause him to break public peace or to commit any other offence and thereby committed an offence punishable under **Section 352 read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023** and within my cognizance.

Fourthly, that you accused on the aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening the informant and prosecution witness with injury to his person and thereby committed an offence punishable under **Section 351(2)(3) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023** and within my cognizance.

Fifthly, that you accused on the aforesaid date, time and place, in furtherance of your common intention, committed mischief and caused wrongful loss or damage to the windows, door of the house and chair of the informant to the amount of more than Rs.50/- and thereby committed an offence punishable under **Section 324(4) read with Section 3(5) of the Bharatiya Nyaya Sanhita, 2023** and within my cognizance.

Lastly, that you accused on the aforesaid date, time and place, in furtherance of your common intention, knowing reason to believe that an offence has been committed, causes evidence of the commission of that offence to disappear, with the intention of screening the offender from legal punishment and thereby committed an offence punishable under **Section 238 read with Section 3(5) of the Bharatiya Nyaya Sanhita 2023** and within my cognizance.

And I hereby direct that you be tried by this Court for the aforesaid charges.
