CHARGE

I, Dhananjay A. Deshpande, Additional Sessions Judge, Sangamner do hereby charge you :-

Shrirkant Popat Nile,
Age 23 Years, Occu.- Labourer
R/o. Kauthe Dhandarphal,
Tal. Sangamner, Dist. Ahmednagar.

as follows :

That you accused, from 18/12/2021 at about 6.00 p.m. to 11/08/2023 within the jurisdiction of Sangamner Taluka Police Station and outside the said jurisdiction i.e. in the residential house of informant situated in the village of Nimgaon Paga, Tal. Sangamner, Dist. Ahmednagar, committed rape on minor victim girl under the age of 16 years and you have thereby committed an offence punishable u/s. 376 (3) of the Indian Penal Code and within my cognizance.

Secondly, that you accused on the aforesaid date, time and place, kidnapped the minor prosecutrix, age 14 years from the lawful guardianship and you have thereby committed an offence punishable u/s. 363 of the Indian Penal Code and within my cognizance.

Thirdly, that you accused on the aforesaid year and place, committed penetrative sexual assault by penetrating your penis in to vagina of minor victim and thereafter repeatedly committed aggravated penetrative sexual assault on minor victim and you have thereby committed an offence under section 3 punishable u/s. 4 of the Protection of Children from Sexual Offences Act, 2012 and within my cognizance.

Fourthly, That you accused on aforesaid year and place, repeatedly committed penetrative sexual assault on the minor child girl, aged under 16 years thereby making the child pregnant as a consequence of sexual assault and you have thereby committed an offence punishable under section 5, j(ii) of the Protection of Children from Sexual Offences Act, 2012 punishable u/s. 6 of the said Act and within my cognizance.

And I do hereby direct that you be tried by this Court for the aforesaid charge.
