that, on dated 02.12.2022, at about 13.30 P.M., at agricultural land bearing Gat No. 179 at Javalke, Tal. Kopargaon, Dist. A.Nagar, accused you No. 1 to 17 & 19 along with deceased accused No. 18 were members of an unlawful assembly, intentionally joins that assembly, or continues in it, and thereby committed an offence punishable under Section 143, of the Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you No. 1 to 17 & 19 along with deceased accused No. 18, were members of an unlawful assembly, the common object of which was to cause hurt to informant and witness and thereby committed an offence punishable under section 147 of the Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you No. 1 to 17 & 19 along with deceased accused No. 18, were members of an unlawful assembly, the common object of which was to cause hurt to informant and witness and that you accused No. 1 and 2 time armed with deadly weapons like wooden danda and thereby committed an offence punishable under section 148 of the Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of

the common object of the said assembly, viz. was voluntarily causing hurt to informant and witness and that time accused you No. 1 & 2 assaulted wife of informant's brother-in-law or used criminal force to her intending to outrage her modesty or knowing it to be likely that you will thereby outrage her modesty and thereby committed an offence punishable under section 354, r/w Section 149 of Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, and that time accused you No.1 and 2 voluntarily caused hurt to wife of her brother-in-law by means of dangerous wepaon i.e. wooden danda used as a weapon of offence & there was likelihood to cause death and thereby committed an offence punishable under section 324 read with section 149 of Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, and that time accused you voluntarily caused hurt to informant and witnesses and thereby committed an offence punishable under section 323 read with section 149 of Indian Penal Code and within my cognizance;

that, on the aforesaid date, time and place, accused you,

were members of an unlawful assembly and in prosecution of the common object of the said assembly, intentionally insulted to informant and witness and thereby gave provocation to them intending or knowing it to be likely that such provocation would cause to them to break public peace and thereby committed an offence punishable under section 504 read with section 149 of Indian Penal Code, and within my cognizance;

that, on the above date, time and place, accused you were members of an unlawful assembly and in prosecution of the common object of the said assembly, committed criminal intimation by giving threatening to informant and witness with intent to alarm them and thereby committed offence punishable under section 506 read with section 149 of Indian Penal Code;

that, on the above date, time and place, accused you were members of an unlawful assembly and in prosecution of the common object of the said assembly and in that scuffle you accused No.1 caused loss by damaging mobile of informant and thereby she sustained loss amounting more than Rs. 50/- and thereby committed offence punishable under section 427 read with section 149 of Indian Penal Code.

And I hereby direct that you be tried by the said Court on the said charge.
