as follows :

That you accused persons on 13.07.2023 in between 20:15 hrs. to 20.30 hrs., in front of open place of Maruti temple, at Sangavi Bhusar, Tal. Kopargaon, Dist. Ahilyanagar you were member of unlawful assembly, the common object of which was to assault the informant and witnesses and thereby committed an offence punishable under section **143 of I. P. C.** and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of the said assembly, used force or violence in prosecution of the common object of such assembly and thereby committed an offence of rioting punishable under section **147 of I. P. C.** and within my cognizance.

Thirdly, that you accused persons on above said date, time and place were a member of unlawful assembly and in prosecution of the common object of the said assembly beat the informant and witnesses by means of fists and blows, voluntarily cause hurt to the informant and witnesses to extort Mobile Phone of Company Vivo Y-12 and and thereby committed an offence punishable under Section **327 read with section**

149 of The Indian Penal Code 1860 and within my cognizance.

Fourthly, that on the aforesaid date, time and place you accused were a member of unlawful assembly and in prosecution of the common object of the said assembly committed mischief of amount more than Rs. 50/- and thereby committed an offence punishable under **Section 427 read with 149** of I. P. C. and within my cognizance.

Fifthly, on the aforesaid date, time and place you accused were a member of unlawful assembly and in prosecution of the common object of the said assembly, intentionally insulted and thereby gave provocation to the informant intending that such provocation would cause to him to break the public peace and that you thereby committed an offence punishable under **Section 504 read with 149** of of the Indian Penal Code and within my cognizance.

Lastly, on the aforesaid date, time and place, on the aforesaid date, time and place you accused were a member of unlawful assembly and in prosecution of the common object of the said assembly threatened the informant to falsely implicate in criminal cases and to remove him from the village and thereby committed an offence punishable under **Section 506 read with 149** of I. P. C. and within my cognizance of the Indian Penal Code and within my cognizance.

And I direct that you be tried by this Court on above charges.
