as follows:

That, on dated 26.01.2023, at about 9.10 p.m., in the area of Sangvi Bhusar, Tal. Kopergaon, Dist. Ahmednagar, accused you were members of an unlawful assembly, the common object of the said assembly, was voluntarily causing hurt to informant, insulting and threatening him with intent to alarm him and thereby committed an offence punishable under section 143 of the Indian Penal Code and within my cognizance;

That, on the aforesaid date, time and place, accused

you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, viz. was voluntarily causing hurt to informant, insulting and threatening him with intent to alarm him and thereby committed an offence of rioting punishable under section 147 of Indian Penal Code and within my cognizance;

That, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and at that time were armed with deadly weapons namely iron weapon and wooden danda and thereby committed an offence punishable under section 148 of Indian Penal Code and within my cognizance;

That, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, and that time accused you No.1 and 2 voluntarily caused hurt to informant by means of iron weapon and wooden danda respectively, used as a weapons of offence, there was likelihood of death and thereby committed an offence punishable under section 324 read with section 149 of Indian Penal Code and within my cognizance;

That, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, and that time accused you voluntarily caused hurt to informant by means of fists and kick blows and thereby committed an

offence punishable under section 323 read with section 149 of Indian Penal Code and within my cognizance;

That, on the aforesaid date, time and place, accused you, were members of an unlawful assembly and in prosecution of the common object of the said assembly, intentionally insulted to informant and thereby gave provocation to him intending or knowing it to be likely that such provocation would cause to him to break public peace and thereby committed an offence punishable under section 504 read with section 149 of Indian Penal Code, and within my cognizance.

That, on the above date, time and place, accused you were members of an unlawful assembly and in prosecution of the common object of the said assembly, committed criminal intimation by giving threatening to informant with intent to alarm him and thereby committed offence punishable under section 506 read with section 149 of Indian Penal Code and within my cognizance.

That, on the above date, time and place, accused you were members of an unlawful assembly and in prosecution of the common object of the said assembly, causing disappearance of evidence of offence with intention of screening of screening the offenders from legal punishment and thereby committed offence punishable under section 201 read with section 149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by the said Court on the said charge.
