C H A R G E

I, Haribhau R. Waghmare, Additional Sessions Judge, Newasa, Dist. Ahmednagar, do hereby charge you accused

1. Santosh Kundalik Gatkhal, Age - 40 years,
2. Kundalik Laxman Gatkhal, Age - 65 years,
3. Rukhamini Kundalik Gatkhal, Age - 60 years,
No.1 to 3 R/o.Telkudgaon, Tal. Newasa, Dist. Ahmednagar
4. Hirabai @ Shakuntala Ramesh Kolte, Age - 45 years,
R/o.Shahapur, Tal. Newasa, Dist. Ahmednagar
5. Bhamabai @ Laximibai Bapurao Khatik, Age - 41 years,
R/o.Patharwala, Tal. Newasa, Dist. Ahmednagar

as follows,

That after three to four months of 06.05.2006 till 19.04.2020 at about 00.00 hours at village Telkudgaon, Tal. Newasa, Dist. Ahmednagar, you accused in furtherance of your common intention, subjected to deceased Mira Santosh Gatkhal cruelty and harassment by demanding Rs.70,000/- which were expended for engagement ceremony of her sister in law and for harvesting Onion so also by beating and abusing the deceased and thereby committed an offence punishable Under **Section-498A r/w 34** of the Indian Penal Code and within my cognizance.

Secondly, that on 19.04.2020 at about 00.00 hours to 07.30 a.m. at village Telkudgaon, Tal. Newasa, Dist. Ahmednagar, deceased Mira had committed suicide and you accused had abated the same by extending cruelty and harassment to deceased Mira by making unlawful

demand of Rs.70,000/- which were expended for engagement ceremony of her sister in law and for harvesting Onion, harassing and abusing the deceased and thereby committed an offence punishable Under **Section-306 r/w 34** of the Indian Penal Code and and within my cognizance.

Thirdly, during the aforesaid period, time and place, you accused in furtherance of your common intention, voluntarily caused hurt to the deceased Mira and thereby committed an offence punishable under **Section-323 r/w 34** of Indian Penal Code and within my cognizance.

Fourthly, during the aforesaid period, time and place, you accused in furtherance of your common intention abused the deceased Mira and thereby intentionally insulted her intending or knowing it to be likely that such provocation will cause her to break the public peace or to commit any other offence and thereby committed an offence under **Section-504 r/w 34** of the Indian Penal Code and within my cognizance.

Lastly, during the aforesaid period, time and place, you accused in furtherance of your common intention committed criminal intimidation by threatening the deceased Mira and thereby committed an offence under **Section-506 r/w 34** of the Indian Penal Code and within my cognizance.

And, I hereby, direct that you be tried by me for the said charge.
