JUDGMENT

Today accused No.2 to 10 and 12 present before the Court. They submitted pursis at Exh.02 to 11 respectively on the record and accordingly they voluntarily plead guilty. Their plea appears to be voluntary and same is accepted. On the point of punishment, I inquired with accused. They submitted that, they are economically poor person and being the only earning member of their family. Thus, they prayed for leniency while imposing sentence. Hence, considering their submissions and considering record, I pass following order :-

ORDER

- 1) Accused No.2 to 10 and 12 are convicted for the offence punishable under section 12(a) of the Maharashtra Prevention of Gambling Act, 1887 as per section 252 of the Code of Criminal Procedure.
- 2) Accused No.2 to 10 and 12 are sentenced to suffer simple imprisonment till rising the court and shall pay fine of Rs.500/- (Rupees Five Hundred Only) each for the offence punishable under section 12(a) of the Maharashtra Prevention of Gambling Act, 1887, in default they shall suffer simple imprisonment for 15 days to each.
