2. Today I have brought the MLC register for the year 2020. On 22.04.2020 the patient namely Namdev Punaji Lande and Ujwala Namdev Lande to came to the Rural Hospital Akole with police yadi. I personally

examined the patient. On personal examination of Namdev Punaji Lande I found the following injuries on his person.

1. Blunt Trauma over mouth evidence of fracture right lower second carried tooth.

Age of injury was within 6 hours. Nature of injury is grievous. Caused of injury is hard and blunt object. I referred the patient of dental opinion. Alleged history was assault on 22.04.2020 at 09:30 a.m.

3. Accordingly I issued medico legal certificate. Now it is shown to me, which is the same. It bears my signature and seal of the rural hospital. Contents in its are true and correct It is at **Exh. 29**. The injuries mention in at Exh. 29 can be caused if a person assaulted with fist and blows.

4. On personal examination of patient Ujwala Namdev lande I found the following injuries on her person. Abrasion over right forearm over wrist joint. Size of injury is 2x1 cm. Transfers simple injury. Age of injury is within 6 hours. Nature of injury is simple, Caused by hard and blunt object. Accordingly I issued medico legal certificate. Now it is shown to me, which is the same. It bears my signature and seal of the rural hospital. Contents in its are true and correct It is at **Exh. 30**. The injuries mention in at Exh. 30 can be caused if a person assaulted with fist and blows.

5. It is true to say that, it was not necessary to admit patient namely Namdev Punaji Lande. It is true to say that they was no injury on head and chest of patient Namdev Punaji Lande. It is true to say that the medico legal certificate at exh. 29 had been issued prior to dental opinion. It is true to say that, the patient never came to rural hospital after dental opinion. It is not true to say that, the patient never came to the rural hospital and I never examined him. It is true to say that the injury in mentioned in exh. 29 if a person falled down on the hard surface.

6. It is true to say that, the Injury mentioned in exh. 30 can be self inflicted. It is true to say that, the abrasion cannot be caused caching hand. It is not true to say that, the patient never came to the rural hospital and I never examined her.
