**ORDER BELOW EXH. NO. 1.**

Perused the application. Also perused the say filed by the I. O. and learned APP. I have gone through the documents filed on record, it transpires that the applicant is the legal possessor of the vehicle **TATA LPK 2518 CREBS-4** bearing registration No. **MH-02-ER-6315**.

2) Being owner of the said vehicle applicant is entitled for getting custody of the same. However considering the objection by Ld. APP it seems property to impose appropriate condition. Hence, I pass the following order.

ORDER

01. The application is allowed.

02. Seized muddemal i. e. vehicle e **TATA LPK 2518 CREBS-4** - bearing registration no. **MH-02-ER-6315** of Chassis no. **MAT448210J3J28582**, Engine no. **ISB5.9B4S180K181J63727173** in connection with **C. R. No. 72/2026** for the offense punishable under section 303(2), 115(2), 352, 351(2), 3(5) of Bharatiya Nyaya Sanhita, 2023 and registered with Rahata police station, be given in interim custody of applicant **Dada Punja Gaikwad**, Age: 68 years, R/o Kasare, Nannaj Dumala, Tal Sangmner, District Ahmednagar. On his due identification and furnishing indemnity bond of Rs. 40,00,000/- (Rs. Forty Lac only) on following conditions that;

A) The applicant shall not alienate or transfer in any way the subject vehicle till the final disposal of **C. R. No. 72/2026** and the

criminal case incident thereto.

- B) The applicant shall also submit colored photographs of subject vehicle sufficient to identify it. He shall also not change its colour, model or major parts without prior sanction of this Court.
- C) The applicant shall produce subject vehicle as and when ordered by the Court.
- D) The applicant shall produce his residential address proof before police while furnishing Supurtnama to the I. O.
- 3) The investigation officer shall verify the original documents and prepare detailed panchnama before handing over the vehicle.
- 4) Information of the order be given to the concerned police station accordingly.
- 5) Needless to say that breach of any of the above conditions shall result in vacating this order.
- 6) Investigating Officer shall annex the bond along with final report.
