As follows ...

That you accused Nos. 1 to 4 on 05.09.2023 at about 08.30 P. M. in the vicinity of village Bramhni, Tq. Rahuri, Dist. Ahmednagar, at agricultural field of the informant bearing Gat No. 167 in furtherance of your common intention committed house trespass by entering into house of the informant, used for human dwelling, having made preparation of causing hurt to the informant and the witnesses and thereby committed an offence punishable **under Section 452 r/w section 34 of the Indian Penal Code** and within my cognizance.

That you accused Nos. 1 to 4, on above mentioned date, time and place in furtherance of your common intention, wrongfully confined son of the informant and thereby committed an offence punishable **under section 342 r/w 34 of the Indian Penal Code** and within my cognizance.

That you accused Nos. 1 to 4 on the above said date, time and place in furtherance of common intention did a act endangering life or personal safety of other by pelting stones and thereby committed an offence punishable **under section 336 r/w 34 of the Indian Penal Code** within my cognizance.

That you accused No. 1 to 4 on above mentioned date, time and place, in furtherance of your common intention, caused hurt to the informant and the witnesses and thereby committed an offence punishable **under section 323 r/w 34 of the Indian Penal Code** and within my cognizance.

That you accused Nos. 1 to 4 on the above said date, time and place, in furtherance of your common intention, intentionally insulted to the informant and the witnesses by giving abuses in filthy language, thereby gave provocation intending or knowing it to be likely that such provocation will cause them to break public peace or to commit any other offence and thereby committed an offence punishable **under Section 504 r/w Section 34 of the Indian Penal Code** and within my cognizance.

That you accused Nos. 1 to 4 on the above said date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening the informant and the witnesses with intent to cause alarm to them and thereby committed an offence punishable **under Section 506 r/w Section 34 of the Indian Penal Code** and within my cognizance.
