

Deposition of Witness No. 3 for the Prosecution.

I do hereby on solemn affirmation state that -

Examination-in-chief by Shri.Darade A.P.P. for State

1] On 11-5-2015 I was working as casualty medical officer at Rural Hospital Shevgaon. On the same day patient namely Jyotiram Jagannath Shelke came to my hospital with police yadi. He stated history of assault since 1.00 pm on 10-5-2015 till 11.00 pm on 10-5-2015. On examination I found following injuries.

1. Contusion 2x2 cm over right infra scapular region
2. Contusion 15x2 cm, two in number over back
3. Contusion 10x5 cm over right thigh
4. Swelling over left dorsum hand
5. Contusion 10x2 cm over left thigh
6. Swelling over bilateral eyes
7. All these injuries are caused due to hard and blunt object.

2] X ray was done for injury no.4 at Civil Hospital Ahmednagar. It was suggestive of fracture left second metacarpale. Age of all these injuries was within 12 hrs. Nature of all the injuries except injury no.4 was simple and nature of injury no.4 was grievous. After giving primary treatment patient was referred to civil hospital Ahmednagar. I prepared his medical certificate accordingly. Now medical certificate is shown to the witness. It is the same. It bears my signature. Its contents are true and correct. It is collectively marked at Exh. 93. All these injuries except injury no.6 may be caused when hit with

iron rod and wooden stick. Injury no.6 may be caused due to fist and kick blows.

Chief examination is over.

Cross-examination by Adv. Shri. L. H. Lande for accused :

3] It is true to say that patient was conscious and he was walking on his own legs when he came to my hospital. It is true to say that patient did not mention the description of weapons with which alleged assault took place. It is not true to say that patient did not orally mention the date and time of alleged assault on him. It is not true to say that I have not noted date and time of alleged assault on the patient in the history of assault in MLC. It is true to say that I have not brought X ray of the patient with me today to the court.

Q. In this event in order to prove injury no.4 there is nothing except your oral words ?

A. I have not brought X ray with me however, I have noted it down in the MLC.

4] It is not true to say that I have mentioned nature of injury no.4 as grievous without X ray, depending only upon my general knowledge. It is true to say that the age of injury mentioned in the MLC is in the approximate range and not the exact time.

Q. The patient was treated on OPD basis ?

A. I gave primary treatment to the patient and referred him to civil hospital Ahmednagar. I do not know what happened further.

5] It is true to say that I do not know about the treatment given to the patient at Civil Hospital Ahmednagar. Witness volunteers that Civil Hospital Ahmednagar had sent X ray report of the patient to Rural Hospital, Shevgaon on 25-5-2015. It is true to say that the report of detailed treatment given to the patient at Civil Hospital Ahmednagar is not available with me till date except X ray report of the patient. It is true to say that all the injuries no.1 to 6 mentioned in the MLC may be possible if a person riding a motorcycle on a

bumpy road falls from the motorcycle. It is not true to say that I prepared a false medical certificate to help the patient. It is not true to say that I am deposing falsely before the court today.
