That you accused No.1 being the husband of the complainant and accused No. 2 to 7 are being relatives of her husband in between may, 2022 to 03.06.2023 at Mhakar, Tal Ambad, Dist. Jalna, in furtherance of your common intention, subjected complainant cruelly by harassing and ill-treating her

physically and mentally by making unlawful demand of money of Rs.5,00,000/- for construction of house, which according to the accused persons were not given to them by her parents and on the said count physically and mentally assaulted, harassed and threatening her etc. the said cruelty which was of such a nature which to cause grave injury or danger to her life, limb or health, and thereby you have committed an offence punishable under Section **498-A r/w 34** of the Indian Penal Code and within my cognizance.

02. That you all accused, on the aforesaid date, time and place, in furtherance of your common intention, on the count of illegal demands of money voluntarily caused hurt to complainant by fist and kick blows and thereby committed an offence p/u/s **323 r/w sec.34** of Indian Penal Code and within my cognizance.

03. That you all accused, on the aforesaid date, time and place, in furtherance of your common intention, intentionally insulted and thereby gave provocation to complainant intending that such provocation would cause them to break the public peace or to commit offence and thereby committed an offence p/u/s **504 r/w sec. 34** of Indian Penal Code and within my cognizance.

04. That you all accused, on the aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening complainant with injury to their person with intent to cause alarm to them and thereby committed an offence p/u/s. **506 r/w sec.34** of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by me for the aforesaid charges.
