C H A R G E

I, D.R. Kulkarni, Judicial Magistrate F.C. Court No.3
Shevgaon hereby charge you,

Genu @ Kalu Rambhau Kapase, **Age - 40 Years,**
Accused R/o. Aantarwali Bk.,
Tal. Shevgaon, Dist. Ahilyanagar.

as follows :

That you accused, on 13.10.2024 at about 11.00 a.m. at Murliphata, Aantarwali Bk., Shivar, Shevgaon road, Tal. Shevgaon Dist. Ahmednagar, runs your bullock cart so rashly and negligently and thereby gave dash to motorcycle bearing registration No. MH. 16 W. 7686 and thereby caused death of brother of complainant Pandurang Vitthal Ubale, not amounting to culpable homicide, who travelling in that motorcycle and thereby committed offence punishable under **Sec.106(1)** of B.N.S. & within my cognizance.

2. That, you accused on the above mentioned date, time and place of incidence by running your bullock cart so rashly and negligently and thereby gave dash to motorcycle of brother of complainant Pandurang Ubale and thereby caused his death and escape without reporting it to police officer or a magistrate soon after the incident and thereby committed offence punishable under **Sec.106(2)** of B.N.S. & within my cognizance.

3. That, you accused on the above mentioned date, time and place of incidence runs your bullock cart so rash and negligent manner and gave dash to the motorcycle bearing registration No. MH. 16 W. 7686 and caused injury to any other persons and thereby committed an offence punishable under **Section 125(a)** of B.N.S. and within my cognizance.

4. That, you accused on the above mentioned date, time and place of incidence runs your bullock cart so rash and negligent manner and gave dash to the motorcycle bearing registration No. MH. 16 W. 7686 caused grievous injury to complainant's brother Pandurang Vitthal Ubale and thereby committed an offence punishable under **Section 125(b)** of B.N.S. and within my cognizance.

5. That, you accused, on above mentioned date, time and place, were found driving above said vehicle, in a manner which was dangerous to the public having regard to the circumstances of the case and thereby committed an offence punishable under **Section 184** of The Motor Vehicle Act and within my cognizance.

6. That on the aforesaid date, time and place, you did not provide medical aid to above named deceased by conveying them to nearest hospital and did not give any information to the police and thereby committed breach of **Section 134(a)(b)** and thereby committed an offence punishable under **section 177** of The Motor Vehicles Act and within my cognizance.

7. That, you accused on the above mentioned date, time and place of incidence committed mischief by causing wrongful loss or damage to the motorcycle of injured witness having registration

No. MH. 16 W. 7686 and thereby committed an offence punishable under Sec. **324 (4)** of B.N.S. and within my cognizance.

And I hereby direct that you be tried by me for the aforesaid charges.
