1] **Firstly**, that you all accused in furtherance of your common object on 17.10.2025 at 18.30 p.m in village Madhi, in front of house of

informant voluntarily caused hurt to the informant and others by dangerous weapon i.e. wooden stick and axe and thereby committed an offence punishable under **Section 118(1) r/w Section 190** of the Bhartiya Nyay Sanhita and within my cognizance.

2] Secondly, that you all accused in furtherance of your common object on the aforesaid place, date and time voluntarily caused hurt to the informant and others with fist and leg blows and thereby committed an offence punishable under **Section 115(2) r/w Section 190** of the Bhartiya Nyay Sanhita and within my cognizance.

3] Thirdly, that you all accused in furtherance of your common object on the aforesaid place, date and time were members of unlawful assembly common object of which was to commit an offence and assaulted informant and others and thereby committed an offence punishable under **Section 189(2) r/w 190** of the Bharatiya Nyaya Sanhita and within my cognizance.

4] Fourthly, that you all accused in furtherance of your common object on the aforesaid place, date and time were members of unlawful assembly committed offence of rioting and thereby committed an offence punishable under **Section 191(2) r/w Section 190** of the Bharatiya Nyaya Sanhita, and within my cognizance.

5] Fifthly, that you all accused in furtherance of your common object on the aforesaid place, date and time were members of unlawful assembly committed offence of rioting with deadly weapon or a weapon of offence used as weapon is likely to cause death and thereby committed

an offence punishable under **Section 191(3) r/w Section 190** of the Bharatiya Nyaya Sanhita, and within my cognizance.

6] **Sixthly**, that you all accused in furtherance of your common object on the aforesaid place, date and time intentionally insulted the informant and others and gave them provocation with intent to provoke breach of peace and thereby committed an offence punishable under **Section 352 r/w Section 190** of the Bhartiya Nyay Sanhita and within my cognizance.

7] **Lastly**, that you all accused in furtherance of your common object on the aforesaid place, date and time committed criminal intimidation by threatening the informant and others and that you thereby committed an offence punishable under **Section 351(2) r/w 190** of Bhartiya Nyay Sanhita, and within my cognizance.

And I hereby direct that you be tried by the this Court for the aforesaid charges.
