CHARGE

I, **Shirishkumar D. Waghmare**, Judicial Magistrate F.C., (Court No.2)
Pathardi, Dist- Ahmednagar do hereby charge you-

- 1] **Raju Laxman Sonune**,
Age: 35 years, Occupation: Agri.,
R/o.: Haral, Tal. Risod, Dist. Washim.
- 2] **Vitthal Madan Khade**,
Age: 22 years, Occupation: Agri.,
R/o.: Yeli, Tal. Pathardi, Dist. Ahmednagar.

As Follows:

- 1] **Firstly**, that you all accused in furtherance of your common object with three unknown persons, on 18.10.2021, at 02.27 p.m in village Pathardi by showing off revolver voluntarily caused grievous hurt to the informant with deadly weapon i.e. Wooden Stick and thereby committed an offence punishable under **Section 326 r/w Section 149** of the Indian Penal Code and within my cognizance.
- 2] **Secondly**, that you all accused in furtherance of your common object with three unknown persons on the aforesaid date, time and place used and kept in your possession revolver without a valid license and thereby committed an offence punishable under **Section 4 r/w 25** of Indian Arms Act, and within my cognizance.
- 3] **Thirdly**, that you all accused in furtherance of your common object with three unknown persons on aforesaid date, time and place were members of unlawful assembly common object of which assaulted him by wooden stick and thereby committed an offence punishable under **Section 143 r/w 149** of Indian Penal Code, and within my cognizance.
- 4] **Fourthly**, that you all accused in furtherance of your common object with three unknown persons on the aforesaid place, date and time were



members of unlawful assembly common object of which committed offence of rioting and thereby committed an offence punishable under **Section 147 r/w 149** of Indian Penal Code, and within my cognizance.

5] **Fifthly**, that you all accused in furtherance of your common object with three unknown persons on the aforesaid place, date and time were members of unlawful assembly committed offence of rioting with deadly weapon or a weapon of offence used as weapon is likely to cause death and thereby committed an offence punishable under **Section 148 r/w 149** of Indian Penal Code, and within my cognizance.

6] **Lastly**, that you all accused in furtherance of your common object with three unknown persons on the aforesaid place, date and time punishable with has been committed did cause evidence of said evidence to disappear, or knowingly given false information the intention of screening the offender from legal punishment and thereby committed an offence punishable under **Section 201 r/w 149** of the Indian Penal Code, and within my cognizance.

And I hereby direct that you be tried by the this Court for the aforesaid charges.
