



CHARGE

I, **Shirishkumar D. Waghmare**, Judicial Magistrate F.C., (Court No.2)
Pathardi, Dist- Ahmednagar do hereby charge you-

- 1] **Pappu @ Ramkisan Karbhari Satpute**,
Age: 29 years, Occupation: Agri.,
R/o. : Sakegaon, Tal. Pathardi,
Dist. Ahmednagar.

As Follows:

- 1] **Firstly**, that you accused on 15.02.2018 at 06.00 p.m in village Sakegaon, Tq. Pathardi, Dist. Ahmednagar committed mischief by causing wrongful loss or damage to the property i.e. Car No. MH-16-BY-6655 and thereby committed an offence punishable under **Section 427** of Indian Penal Code and within my cognizance.
 - 2] **Secondly**, that you accused on aforesaid place, date and time voluntarily caused hurt for the purpose of extorting from the said informant or for the purpose of constraining or which may facilitate the commission of offence and thereby committed an offence punishable under **Section 327** of the Indian Penal Code and within my cognizance.
 - 3] **Thirdly**, that you accused on aforesaid place, date and time with the absconding accused you committed theft of cash amount Rs.15,400/- (Rupees Fifteen Thousand Four hundred) and violently carried away and voluntary caused hurt or wrongfully restrained or fear of instant hurt to the informant and thereby committed an offence punishable under **Section 392** of the Indian Penal Code and within my cognizance.
 - 4] **Fourthly**, that you accused on the aforesaid place, date and time caused hurt to the informant by kick and fist blows and thereby committed an offence

punishable under **Section 323** of Indian Penal Code and within my cognizance.

5] **Fifthly**, that you accused on the aforesaid place, date and time intentionally insulted the informant and gave them provocation intending it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable under **Section 504** of the Indian Penal Code and within my cognizance.

6] **Sixthly**, that you accused on the above aforesaid mentioned place, date and time accused threatened to the informant to kill them with intent to cause them alarm and thereby committed an offence punishable under **Section 506** of Indian Penal Code and within my cognizance.

7] **Lastly**, that you accused on the aforesaid place, date and time punishable with has been committed did cause evidence of said evidence to disappear, or knowingly given false information the intention of screening the offender from legal punishment and thereby committed an offence punishable under **Section 201** of the Indian Penal Code, and within my cognizance.

And I hereby direct that you be tried by the this Court for the aforesaid charges.
